TELANGANA BILLS
TELANGANA LEGISLATIVE ASSEMBLY

The following Bill was introduced in the Telangana Legislative Assembly on 30th August, 2016.

L.A. BILL No. 11 OF 2016.

A BILL FURTHER TO AMEND THE CYBERABAD (METROPOLITAN AREA) POLICE ACT, 2004.

Be it enacted by the Legislature of the State of Telangana in the Sixty-seventh Year of the Republic of India as follows:-

1. (1) This Act may be called the Cyberabad (Metropolitan Area) Police (Amendment) Act, 2016.

(2) It shall be deemed to have come into force with effect from 15th June, 2016.

Amendment of Section 2. Act No. 2 of 2004.

2. In the Cyberabad (Metropolitan Area) Police Act, 2004 (hereinafter referred to as the principal Act), in section 2,-

(i) in clause (b) after the words "under section 5 to" the words "to the respective Commissionerates of the" shall be inserted.;

(ii) in clause (c) for the words "Ranga Reddy District" the words "of a district, where from the area/s is notified as Cyberabad Metropolitan area under section 8 of the Code of Criminal Procedure, 1973" shall be substituted.

Amendment of section 3.

3. In the principal Act, in section 3, in sub-section (1), for the first and second provisos the following shall be substituted, namely,-

"Provided that in order to maintain better law and order and for more administrative convenience owing to geographic background and rapid urbanization, Government may, by including those areas as may be notified further to be the Cyberabad Metropolitan area under section 8 of the Criminal Procedure Code, 1973, re-organize the Cyberabad Police Commissionerate established under sub-section (1), into such number of Police Commissionerates with specified areas, and such names by notification and on such commencement such number of Police Commissionerates with such areas as notified therein shall be deemed to have been established respectively:

Provided further that the Government may, from time to time, by notification alter the limits of the Commissionerate/s established under this sub-section, so

as to include therein or to exclude there from, the areas specified in the notification.

4. In the principal Act, in section 4 , for sub-section (1), the following shall be substituted, namely,-

“(1) With effect from the date of establishment of the Cyberabad Metropolitan Police Commissionerate/s, the Police Force functioning in the said Metropolitan Area shall be deemed to be the Police Force of such Metropolitan areas, respectively.

5. In the principal Act, in section 5,-

(i) in sub-section (1), the words “Commissioner of Cyberabad for the metropolitan area” shall be substituted with the words “the Commissioner of the respective Police Commissionerate”;

(ii) in sub-section (3) , the word “Cyberabad” shall be substituted with “of the respective Police Commissionerate.”;

6. In the principal Act, in section 7, wherever the word “Commissionerate” occurs, shall be substituted with the word “Commissionerate/s”.

7. In the principal Act, in section 9, the word “Commissionerate” shall be substituted with the word “Commissionerate/s”.

8. The Cyberabad (Metropolitan Area) Police (Amendment) Ordinance, 2016 is hereby repealed.

STATEMENT OF OBJECTS AND REASONS

According to section 3(1) of the Cyberabad (Metropolitan Area) Police Act, 2004 the areas as notified by the Government as Cyberabad Metropolitan Area under section 8 of the Cr.P.C., 1973 shall be the Cyberabad Police Commissionerate for the purpose of the Act and on such commencement the Cyberabad Police Commissionerate shall be deemed to have been established for the said Metropolitan Area of Cyberabad. Section 3 further provides for altering the limits of the said Commissionerate either by inclusion or by exclusion, but not to form a new Commissionerate or to divide the Commissionerate.

2. In order to maintain better law and order and for more administrative convenience owing to geographic background and rapid urbanization, it has been decided to re-organize the Cyberabad Police Commissionerate established under sub-section (1), into such number of Police Commissionerates with such specified areas and names by notification by including those areas as notified further to be the Cyberabad Metropolitan area under section 8 of the Criminal Procedure Code, 1973 by suitably amending section 3 of the Cyberabad (Metropolitan Area) Police Act, 2004, along with necessary amendments connected therewith.

As the Legislature of the State was not then in session the Cyberabad (Metropolitan Area) Police (Amendment) Ordinance, 2016 (Ordinance No. 4 of 2016) has been promulgated by the Governor.

This Bills seeks to replace the said Ordinance.

FINANCIAL MEMORANDUM

Due to the introduction of the Telangana Ordinance No. 4 of 2016, for Amending the Cyberabad (Metropolitan Area) Police Act, 2004 for the bifurcation of the Cyberabad Commissionerate Areas, into Cyberabad Police Commissionerate and the Rachakonda Police Commissionerate, there will be an immediate effect of **Rs. 22.08 crores of recurring and Rs. 122.00** crores of Non-Recurring expenditure on the Consolidated Fund of the State.

MEMORANDUM REGARDING DELEGATED LEGISLATION

Section 3 of the Bill authorizes the Government to issue notifications or to make rules in respect of matters specified therein and generally to carry out the purposes of the Act.

All such rules do made or notifications issued which are intended to cover matters mostly of procedural in nature are to be laid on the Table of the Legislature of the State and will be subject to any modifications made by the Legislature.

The above provisions of the Act regarding Delegated Legislation are thus of normal type and are mainly intended to cover matters of procedure.
