All Members of the Telangana Legislative Assembly are informed that in view of the commencement of the Eighth Session of Second Telangana Legislative Assembly at 11.00 A.M. on Friday, the 24<sup>th</sup> September, 2021, the Hon'ble Speaker, Telangana Legislative Assembly has directed to follow certain **Preventive measures to contain the spread of 'COVID-19'**, as was done in the previous sessions, in the present Session also for the smooth functioning of the House. Apropos, the following guidelines are suggested.

1. Members are informed that necessary arrangements have been made for the Covid-19 Vaccination and also for the Covid-19 Testing in the Assembly premises. Members are requested to avail the facility by providing the Aadhaar Card for the First Dose Vaccination and First Dose Certificate for the Second Dose Vaccination.
2. Wearing of Face Mask is compulsory at all times.
3. Members are **requested not to bring their P.As.** and guests/visitors to the Legislative Assembly premises, inasmuch as their entry is strictly prohibited. The Visitors' passes are not being issued during this Session.
4. Gatherings are to be avoided in the precincts of the Legislative Assembly.
5. Practice frequent hand washing with soap/liquid hand-wash for at least 40-60 seconds even when hands are not visibly dirty and use of alcohol based hand sanitizers for at least 20 seconds. The touch free sanitizer machines and temperature record machines are installed in adequate numbers at various designated places in the precincts of the Legislative Assembly for the convenience of the Members.
6. Respiratory etiquettes to be strictly followed. This includes strict practice of covering one's mouth and nose while coughing/ sneezing with a tissue/ handkerchief/ flexed elbow and disposing off used tissues properly.
7. Spitting in the precincts of the Legislative Assembly, except in specified places (wash area) is strictly prohibited and the Members are requested to kindly adhere to the same.
8. Personal hygiene, social and physical distancing of at least 1 meter to be strictly followed at all times in the precincts of the Legislative Assembly.
9. Any Member reportedly suffering from flu-like illness should avoid attending the Session and he/she has to seek medical advice from the health authorities. Such Members, if diagnosed as a suspect/confirmed case of COVID-19 should immediately apprise the Hon'ble Speaker for further assistance.
10. Shaking of the hands or giving hug to other Members has to be strictly avoided. Self-restraint has to be maintained by avoiding touching your eyes, nose and mouth with hands.
11. In conformity with the pandemic norm insofar as maintenance of physical/ social distancing, the seating arrangements in the House have accordingly been made i.e. every alternate seat has been earmarked as "NO SEATING" which has to be strictly adhered to. Members are requested to cooperate in this regard.

All Members are, therefore, requested to co-operate by adhering to the above directions of the Hon'ble Speaker in its entirety.
